In consideration of permission to participate in the Peppermint Ridge Festival of Trees and Craft Faire at Peppermint Ridge, the undersigned _____ hereinafter known as "Merchant", hereby agrees as follows:

1. Merchant is eighteen (18) years of age or older.
2. During participation in the Peppermint Ridge Festival of Trees and Craft Faire, merchant will observe and obey all regulations of Peppermint Ridge.
3. Merchant will collect, account for, and pay to, appropriate agencies such taxes as may be associated with or derived from participation in the Peppermint Ridge Festival of Trees and Craft Faire.
4. Merchant will be responsible to provide all labor and materials required (including something to weigh down canopy if using one) for participation in the Peppermint Ridge Festival of Trees and Craft Faire. (tables, chairs, canopies, weights etc.)
5. Merchant will stay the full time (10am – 3pm) of the Peppermint Ridge Festival of Trees and Craft Faire for each day of the event.
6. Merchant will make no claims whatsoever against the organization, Peppermint Ridge, on account of personal injury or property loss/damage suffered by merchant during participation in the Peppermint Ridge Festival of Trees and Craft Faire.
7. Merchant shall, at all times, indemnify and hold harmless the organization of Peppermint Ridge or any of its workers/volunteers against all claims, demands, actions, or causes of action which may arise in any manner out of merchant's participation in the Peppermint Ridge Festival of Trees and Craft Faire. Merchant assumes responsibility for loss and/or damage to or of his/her property before, during or after the Peppermint Ridge Festival of Trees and Craft Faire. This includes any property that is stored at Peppermint Ridge.
8. Merchant has examined the advertising campaign for the Peppermint Ridge Festival of Trees and Craft Faire and agrees that it is satisfactory.
9. Merchant understands that money paid for booth space is non-refundable; if the merchant cannot participate because of personal reasons or weather.
10. Merchant will not bring pets.
11. Merchant shall possess a current California resale certificate or Temporary Seller's Permit.
